# ATTACHMENT TO ARTICLES OF AMENDMENT OF THE JEAN CHARLOT FOUNDATION

Items (b) and (c) of Article III of the Charter of Incorporation of the Jean Charlot Foundation (recorded December 5, 1968) are amended to read as follows:

### **ARTICLE III**

The purposes for which the corporation is organized are:

[Item (a) of Article III remains unchanged.]

- (b) To perpetuate the legacy of Jean Charlot by supporting the collection, preservation, documentation and dissemination of resources related to his life, work and interests.
- (c) To encourage artists and scholars in their work through awards and grants and to promote the social and intercultural aspects of art.

[Items (d), (e) and (f) of Article III remain unchanged.]

Article V of the Charter of Incorporation of the Jean Charlot Foundation (recorded December 5, 1968) is amended to read as follows:

### ARTICLE V

All members of the board of directors and all persons who meet the requirements for membership set forth in the by-laws shall be members of the corporation and such memberships shall be evidenced by the membership roll of the corporation. The members of the corporation shall have no interest, present, prospective or contingent, of any kind in the property or assets of the corporation, but shall have such rights, powers and privileges as shall be determined by the board of directors from time to time in accordance with the by-laws.

Subject to the above amendments, the Charter of Incorporation shall remain in full force and effect.
